

Glenwood City Council Minutes
April 26, 2016

Glenwood City Council met in regular session on Tuesday, April 26, at 7:00 p.m. in City Hall Council Chambers. Committee Reports:

1. Council member Hirschman reported for Budget & Finance held at 6:30pm; prior to tonight's meeting to meet with pool committee chair Mary Gunderson and Diana Burchett with the YMCA to discuss safety equipment for Aquatic Center and the 2016 fees. The initial order for the equipment will be about \$3000. Rates for the 2016 season were discussed and decided on \$80 for a family pass (up to 5 people, plus \$5 per additional family member); Single day admission will be \$5 per adult; \$4 for senior citizen (65+); \$3 for students with an ID; and free for ages 4 & under.

Mayor Tackett had met with George at JEO regarding the security system that was originally intended to send and store all information from cameras to the school's existing security camera and storing system. A new option is available with a zero cost change; where the cameras for the aquatic center would relay their information to a local server ; which can be monitored remotely by city personnel.

Public works Director Perry Cook reported the following:

- 1) Diagnostic was done on the N. Walnut siren; costing \$500; waiting to hear back if it can be fixed.

Police Chief Eric Johansen reported the following:

- 1) Shared letter received from the school regarding Northeast Elementary pick up issues on Vine St. The school is recommending to have No Parking be designated on 9th Street and Vine St. north of 9th St. In addition, have all of Vine St. on the east side of the school be designated as a drive thru lane for pick up and drop off; no cars shall be left unattended during a half hour to the start of school to a half hour after school dismissal during school days. Council has asked Johansen to look into this. In addition; Council member Lundvall asked Johansen to do a study at West Elementary on Myrtle St.
- 2) Wants to work on getting some bids for towing services
- 3) Drug take back program is this Saturday at Hy-Vee Pharmacy
- 4) Sgt. Johansen is conducting bike safety classes at the school

Assistant Fire Chief Matt Gray reported the following:

- 1) Want to sell the suburban; will try and get some bids
- 2) EMS Week starting Sunday, May 15 from 1-4pm at Fire Station; will close part of Coolidge St. Activities include a bounce house; dunk tank; water curtain for kids; and demonstrations. Food and drinks provided – free will donation
