Glenwood City Council met in regular session on Tuesday, May 23, at 7:01 p.m. in City Hall Council Chambers. - 2. Council member Susan Hirschman reported for Budget and Finance who met prior to council at 6:30pm to conference with Bob Josten and meet with Aaron Rodenburg to discuss tax abatement for Park Place property; which would not compete with other facilities in town. Council will have Josten prepare two packages for their review.

Departmental Reports:

Public Works Director Perry Cook reported the following:

Police Chief Eric Johansen reported the following:

- 1. Did not receive any sealed bids on the two forfeiture vehicles. Alter Recycling paid \$300 per car. Has a new forfeiture vehicle; a 2001 Mitsubishi that runs and will advertise for closed bids.
 - 2. Conducting annual seat belt "Click it or Ticket" campaign through June 4

- 3. Thanked Laurie Smithers for setting up the Peace Officer Week/Blue Light campaign and the appreciation event held on the courthouse lawn.
 - 4. After testing; there are 12 applicants which will move on in the process

Code Enforcement Officer Devan Hitchcock reported the following;

- 1. O'Reilly update given.
- 2. Citizen who lives in city limits with 9 acres of land inquired if they could be allowed to have more than five chickens. Council was not in favor
 - 3. Sent out 32 abatements for yards.

Library Director Tara Painter reported the following:

- 1. Thanks to public works; the shelves were moved at the library
- 2. Summer reading runs from June 1 through August 21st.
- 3. Library will be providing safe viewing tips and equipment for the August 21st eclipse. Received grant for 200 pairs of viewing glasses which will be given out on a per household basis during the astronomy event at library on June 1
- 4. Having library at the lake (Glenwood Lake Park) on June 8, Jerad Getter form the Conservation Department will be there to talk about fun things to do at park and how to care for our parks.

Clerk Winquist reported the following for the YMCA

- 1. YMCA is planning a YMCA Swim meet the morning of August 19 at the outdoor pool will pay for their own lifequards and will have concessions open. Possible dates for outdoor pool lessons are June 5-15; June 19-29; and July 10-20 from 9:30 to 11am
- 2. Requested authorization to obtain start up cash for the pool in the amount of \$400. Motion by Florian; second by Hirschman to authorize Clerk to get \$400 start up cash for pool Roll call: Aves: 4 Navs: 0 Motion carried
