- 2. Council member Susan Hirschman reported for Budget and Finance who met prior to council at 6:20pm to conference with Bob Josten to discuss possible revitalization for 114 Green Street. Aaron Rodenburg was unable to attend. Discussed deleting Section 3 regarding property tax rebate to owner and adding language for an annual report to be provide to the city Council member McComb gave his reasons why he did not support this. Council member Florian stated he was not comfortable taking the Resolution to a vote tonight.

- 3. Midwest Diving Team sent 3 members to help place weights on static relief valve at the bottom of pool. This group does not charge for their service but will accept donations.

- 4. Received inquiries asking about adding two more handicap parking on north side of senior center. Cook reported it would cost city about \$3400. Cook indicated the city is ADA compliant at this time. Florian suggested the senior center may be willing to share the expense.
- 5. Mayor Tackett has received calls about the welcome to Glenwood sign and the overgrown flowers covering the words. It's been a Master Gardener project for the sign's upkeep; therefore; Linda Washburn has reached out to them for their input.

Police Chief Eric Johansen reported the following:
