  - c. Discussed new contract for animal control -Motion by Smithers; 2<sup>nd</sup> by McComb to approve animal control agreement with Glenwood Veterinary Clinic, with fees for adoptions increasing from \$125 to \$150 and quarantines increasing from \$375 to \$400
