

RESOLUTION # 3550

RESOLUTION ESTABLISHING RATES FOR THE GLENWOOD AQUATIC CENTER

WHEREAS, the City of Glenwood (hereinafter "City") possesses and operates the Glenwood Aquatic Center; and

WHEREAS, the Glenwood City Council desires to set the various rates and charges for the 2021 season; and

WHEREAS, the City adopts said rates and charges for the 2021 season and therefore desires to pass this Resolution affirming the same.

IT IS THEREFORE RESOLVED BY THE CITY COUNCIL OF THE CITY OF GLENWOOD, IOWA, AS FOLLOWS:

1. The rates and charges for use of the Glenwood Aquatic Center for the 2021 season are as follows:

Season Passes (New: reusable passes each year/replacements \$5.00 each)

Individual

Students (Age 5-17)	\$65.00
Adults (Age 18 & Older)	\$75.00
Senior Citizen (62+yrs.)	\$65.00
Military-Active, Retired, Veteran	\$65.00 *Must live in Mills County
Firefighter/EMS/Law Enforcement	\$65.00 *Must live or work in Mills County

Family

Household/Family Pass: \$175.00

Family Passes include Parent(s) and their minor children 17 years and younger residing at the same address only. Maximum 6 family members; two adults (18yrs+) per pass. Additional minor/dependent child can be added for \$10; child must be able to be claimed on your taxes and live at same address.

*Grandparents, aunts, uncles, nieces, nephews, cousins, houseguests and babysitters are **NOT** included for family passes or additional members.

Grandparent, Nanny or babysitter (16 years +) can be added for **\$30.00 to your family pass**, limit two (2) per family pass.

Nanny/babysitter passes can only be used when attending with the children.

***Children 9 & under must be accompanied in the water by someone 16 years or older and in arms reach while in the water.**

DISCOUNTS:

YMCA (active) members receive \$10 discount off single pass or \$15 discount off family pass. **Must show proof of active status.**

Military (Active, Retired, Veteran) receive a \$20 discount off family pass. Must show proof of Military status.

Active law enforcement, fire fighters or EMS receive a \$20 discount off family pass. Must live or work in Mills County and provide proof.

Discounts cannot be combined.

Single Day Admissions:

Adults (18 years and older)	\$5.00
Senior Citizens (62 years +)	\$2.00
Students (Ages 5-17)	\$3.00
Children 4 years and younger	No Charge *Must be with paid adult

Daily Adult Swim 12pm to 1pm - Monday through Friday Only

Adults Only – 18 years and older \$2.00 (Y members free)

Sunday Family Fun Day: Every Sunday (up to 6 in family)

\$15.00

Party Rentals:

Semi-private party (facility still open to the public)

1-15 people \$125.00 – 2-hour limit


16-25 people \$150.00 – 2-hour limit

Private party:	1-25 people	\$200.00
	26-50 people	\$250.00
	50 + people	\$300.00

Private parties are from 8:00 p.m. to 9:30 p.m. – A late fee of \$100.00 will be charged after 9:30 p.m.

2. These rates shall be effective for the season commencing on adoption of this Resolution and shall continue for the 2021 season and thereafter until modified by the Glenwood City Council by way of Resolution. Contact City hall for payment arrangements.
3. Pre-paid punch cards for admission or concessions available for purchase at city hall M-F 7:30am-4:30pm.
