

**City Council Minutes
November 6, 2018**

Glenwood City Council met in regular session on Tuesday, November 6, 2018 at 7:02p.m. in City Hall Council Chambers. Mayor Ron Kohn called the meeting to order with the following present: Council Members: Dan McComb; Craig Florian; Jeremy Rodman and Holly Jackson; City Employees: Tara Painter; Eric Johansen; Perry Cook; Angie Winquist; Amber Farnan; Guests: Rachel Reis and Diana Burchett. Council Member Smithers was absent. Motion by McComb; second by Florian to approve the following consent agenda

Council Member Rodman reported for Budget & Finance who met with Administrator Winquist to review health insurance plans. Group Benefits reported the city can retain their transitional health plan another year with an increase of 8.7% in premium. This plan remains the lowest compared to United Health Care and ACA plans. Winquist presented three proposals from PFM; DA Davidson; and Speer Financial as municipal finance advisors; should council decide to proceed with a bond issue for equipment purchases. Discussed the permit fee for the GCSD activity complex; further discussions to follow. Rodman also reported for Public Safety who met with Code Enforcement Officer Hitchcock to discuss Knox Boxes for city buildings.

Motion by McComb; 2nd by Florian to approve renewal of health insurance with Wellmark BC/BS; with a rate increase of 8.7%

Council Member McComb reported for Public Works Committee of requests to vacate two areas, one west of 1006 Green Street (West Street); the other just off of South Chestnut. Council is requesting written requests from property owners and will have P & Z do study with recommendation.
